GENERAL CONDITIONS SET FORTH IN LA. CODE OF CRIMINAL PROCEDURE ARTICLES 895 AND 895.1

The DEFENDANT IS ORDERED to and shall comply with the general conditions of La. Code of Criminal Procedure articles 895 and 895.1, including, but not necessarily limited to, the following:

- ____ (1) Defendant shall refrain from any criminal conduct-the violation of any federal, state, local or city law.
- ____ (2) Defendant shall report to the Office of Probation and Parole, 991 Gerstner Memorial Blvd. (Highway 14), Lake Charles, Louisiana (337-491-2388) within 48 hours within 48 hours make a full and truthful report at the end of each month and report to the probation officer as directed.
- ____ (3) Defendant shall meet his/her specified family responsibilities, including any obligations imposed I a court order of child support.
- ____ (4) Defendant shall permit the probation officer to visit him/her at his/her home, job or elsewhere.
- ____ (5) Defendant shall pursue approved employment or occupation, or perform community service.
- ____ (6) Defendant shall refrain from owning or possessing firearms or other dangerous weapons.
- ____ (7) Defendant shall refrain from frequenting unlawful or disreputable places or consorting with disreputable persons.
- ____ (8) Defendant shall remain within the jurisdiction of the court and get the permission of the probation officer before making any change in his/her address or his/her employment.
- ____ (9) Defendant shall submit himself/herself to available medical, psychiatric, mental health, or substance abuse examination or treatment or both when deemed appropriated and ordered to do so by the probation or parole officer.
- ____ (10) Defendant shall pay a supervision fee to defray the costs of probation supervision, including the monthly supervised probation fee and the Sex Offender Registry Technology Fund Fee.
- ____ (11) Defendant shall agree to searches of his/her person, his/her property, his/her place of residence, his/her vehicle, or his/her personal effects, or any or all of them, at any time, by the probation or parole officer assigned to him/her, with or without a warrant of arrest or with or without a search warrant, when the probation or parole officer has reasonable suspicion to believe that the person who is on probation is engaging in or has been engaged in criminal activity.

SPECIAL CONDITIONS OF PROBATION APPLICABLE TO THE DEFENDANT

The Defendant shall comply with the following Special Conditions, as marked:

- ____ (1) Defendant shall serve _____ parish jail, to include credit for any time served from date of arrest on this charge.
- ____ (2) Defendant shall Pay a FINE OF \$_____, INDIGENT DEFENDER FUND REIMBURSEMENT OF \$_____, and COURT COSTS.
- ____ (3) Defendant shall Pay RESTITUTION to _____ in the amount of \$ _____, through the Office of Probation and Parole, to be paid _____ in a lump sum or _____ on a monthly basis.
- ____ (4) Defendant shall Pay lab/testing fees to _____ in the amount of \$ _____.
- ____ (5) Defendant shall Pay supervised probation fee of \$60.00, La Commission on Law Enforcement Fee of \$_____ (\$50-\$100 onetime fee for drug offense), a fee of \$11.00 per month for the Sex Offender Registry Technology Fund.
- ____ (6) Perform _____ eight hour days of community service.
- ____ (7) Defendant shall stay away from and avoid all contact with the victim and/or the victim's family and _____.
- ____ (8) Defendant shall obtain a GED.
- ____ (9) Defendant shall attend an Anger Management/Domestic Violence Intervention program.
- ____ (10) Defendant shall submit to random drug and/or alcohol screens and submit to drug/alcohol treatment and evaluation as directed by probation or parole officer.
- ____ (11) Defendant shall not own or possess any firearms pursuant to LA. R.S. 14:95.1
- ____ (12) Defendant is to comply with the following ADDITIONAL SPECIAL CONDITIONS:

I, Defendant, understand that failure to comply with the foregoing conditions may cause my probation to be revoked. During the period of probation, I shall be subject to arrest at any time by the Probation and Parole Officer, either with or without a warrant, for the purposes of returning me to the Court for further disposition. I, Defendant, understand all of the above marked conditions which have been read to me by and discussed with my attorney and I solemnly promise and agree to obey them.
